Beruni can change the morals, lifestyle of young people. Because man can dominate his body. That is why he is able to educate people who are considered bad by their behavior. In doing so, he suggests that he should read books on morality, associate with well-named beautiful people, and be industrious.

Beruni quotes a Greek sage and agrees: "Whoever is proud of his past generations, those generations are alive and he is dead ... or if a person does not exalt himself, the great dead bones will not be the cause of that pride." [1].

Beruni says that in the upbringing of a child in the family, special attention should be paid to keeping his behavior in moderation, which is achieved by protecting the child from severe anger, fear, sadness and insomnia. Children need to be always ready to find what they want and find useful and to keep what they don't like out of sight. There are two benefits to this work. On the one hand, it benefits the child's spirit because bad behavior comes from a variety of client disorders. Also, if bad behavior becomes a habit, it can lead to malignant disorder. For example, anger is intensely heated, grief is strongly debilitating, frustration relaxes the senses, and the client is prone to phlegm. The peculiarity of this is that Beruni encourages women to social work, demands that the whole society and family members should be engaged in productive labor, and glorifies the labor of artisans and farmers. According to him, man is perfect and rasa with his mind and enlightenment. Morality is a condition for the stability of the life of a person, a people, a nation. Immoral qualities lead to the degradation of man, people, and nation, pitting them against universal norms and the eternal laws of life in general. For example, Beruni says that morality is therefore the core of the national spiritual being. The great philosophers of Beruni's time, Farabi and Ibn Sina, also stressed the importance of education in the stage of human development, and social life is the main and most important education.

According to her, at first the woman was intelligent and faithful, shy and honorable, kind and sensible, moderate, loyal to her husband, obedient, kind, carefree, chaste, calm, gentle, and serious and glorious, behaving in every manner. Ibn Sina praises the wisdom of women here, for she is a thrifty person, whose good qualities are evident in her actions, and who can be an ointment to her husband in difficult times. She thinks that if a woman is wise, she can be a trusted friend and sympathizer of her husband, she condemns infidelity, she says that the thing that leads to the destruction of the family is that infidelity. Ibn Sina says that a person should always act freely and freely, a person is responsible for his actions. Ibn Sina, in expressing his views and opinions on the upbringing of children, finds it necessary to begin the upbringing of children by naming them, and considers the choice of a good, appropriate name for children to be one of the noble duties of parents. Today, women, who make up more than half of the population of Uzbekistan, are actively involved in the reform process and make a worthy contribution to the development and prosperity of our country.
