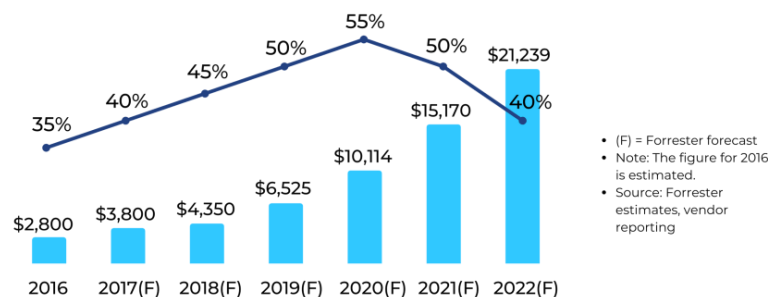

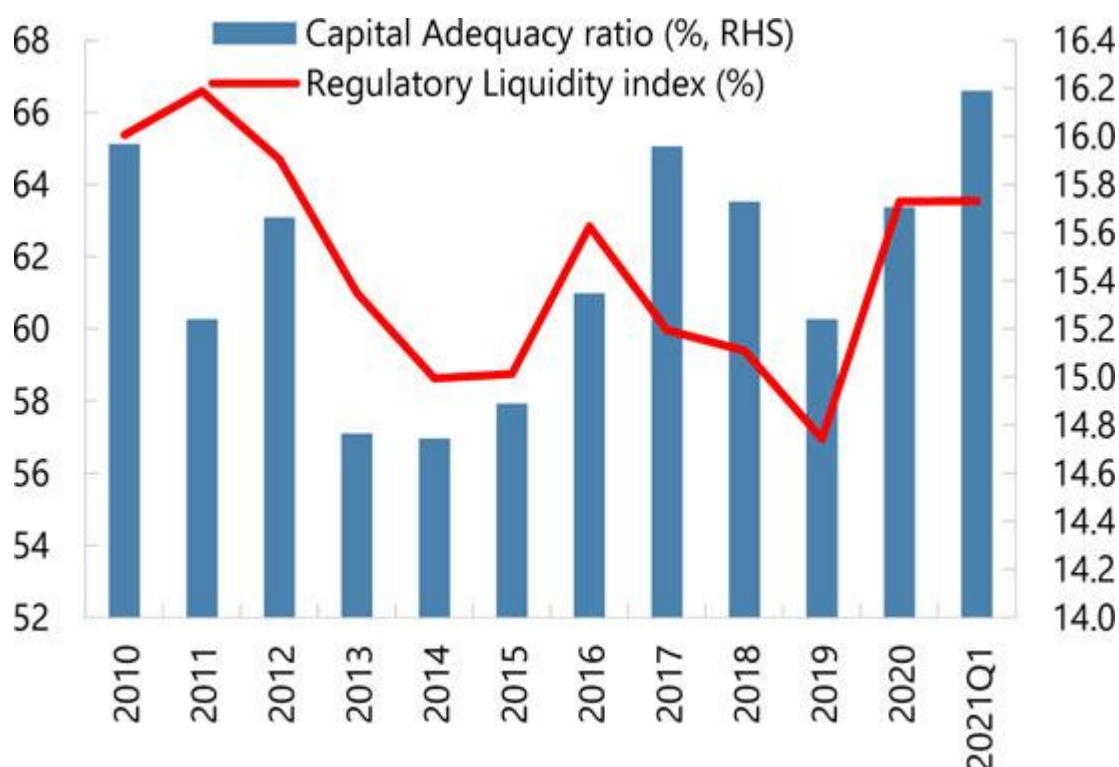

The banking system remained resilient and well-regulated.
